## 5. The obligation to provide us with your personal data

- You are obliged to provide your personal data in case they are processed by the Personal Data Controller in order to fulfil his/her obligations resulting from the legal regulations, i.e.:
  - To fulfil the obligations under tax law.
  - To fulfil the obligations under the GDPR
- The provision of personal data in other cases is voluntary and depends on your decision, but may be necessary for specific purposes, e.g. conclusion of an agreement, conducting correspondence with you.

## 6. Source of data

The Personal Data Controller has obtained your personal data directly from you, from the entity you represent, from the entity on whose behalf you contact us or from publicly available sources.

## 7. Right to withdraw consent

- If the processing of your personal data is based on your consent, you may withdraw your consent at any time, at your own discretion.
- If you would like to withdraw your consent to the processing of your personal data, to do so, it is sufficient to send an email directly to the Personal Data Controller at: [iod@247.com.pl](mailto:iod@247.com.pl) or in the case of cookies, including those using personal data for remarketing purposes, by changing the cookie settings.
- If the processing of your personal data was based on your consent, its withdrawal does not make the processing of your personal data illegal until that moment. In other words, until your consent is revoked, we have the right to process your personal data, and revoking your consent does not affect the lawfulness of processing up to that date.

## 8. Data profiling and automated decision-making

We would like to inform you that your data will be used by us for profiling in connection with the Personal Data Controller's use of remarketing tools, including Meta Pixel.

This allows the Personal Data Controller to target you with personalised advertisements based on your previous activities on the website, which constitutes the so-called "behavioural advertising". ## 9. Personal data recipients

Like most entrepreneurs, in our business activity we use the assistance of other entities, which often involves the need to transfer personal data. Therefore, we may pass your data to external service providers if necessary.

External service providers who are involved in the processing of your personal data are as follows:

- **Hosting companies** that store your data on a server,
- **Technical service providers**, if technical work is included in the operation of the areas where your personal data are stored, e.g. an IT services provider.
- **The cloud computing provider** in which the files containing your personal data are stored;
- **Providers of tools or plug-ins** that are used by the Personal Data Controller;
- **Entities from the area of legal services**, who are subject to professional secrecy obligation and access personal data as a result of a legal necessity,
- **Other subcontractors** who will access the data if necessary.

In addition, we may for example have to pass on your personal data to other entities, whether public or private, on the basis of the applicable law or a decision of a competent authority. For our part, we assure you that we analyse all requests for personal data very carefully and thoroughly so as not to inadvertently pass on the information to an unauthorised person.

## 10. Transfer of personal data to third countries



Yes. In connection with the Personal Data Controller's use of external tools such as the Meta Pixel, your personal data may be transferred e.g. to the USA. The legal basis for the transfer of personal data to the USA is a decision of the European Commission number 10 July 2023 stating an adequate level of protection for personal data provided by the so-called "EU-US Data Privacy Framework". The data transfer is carried out by the tool provider.

#### **11. Period of storage of personal data**

Please note that we do not process your personal data "indefinitely", but for the time necessary to achieve the stated purpose, in accordance with the applicable legal provisions. After this period your personal data will be irretrievably deleted or destroyed.

A description of the processing periods can be found below:

- **Conclusion and performance of an agreement** – data necessary for the conclusion and performance of an agreement will be stored until the agreement has been performed;
- **Contact and handling correspondence** - data related to handling correspondence will be processed for the duration of the correspondence between us,
- **Marketing purposes** – data processed for marketing purposes will be processed until an objection has been successfully made or the purpose of the processing has been achieved – in the case of data processed on the basis of a legitimate interest, and until a consent has been withdrawn or the purpose of the processing has been achieved – in the case of data used for profiling,
- **Use of cookies (other than the cookies necessary for the provision of electronic services) in relation to the activities of recording and reading data from a device** – data related to cookies will be processed until a consent has been withdrawn or the purpose of the processing has been achieved,
- **Analysis of website activity** – data related to website activity analysis will be processed until they have become obsolete or no longer relevant.
- **Archival and evidentiary purposes** – data related to archival and evidentiary purposes will be processed until you have effectively objected to the processing, or the purposes of the processing have been achieved,
- **Establishment, investigation, and defence against claims** – data related to claims will be processed until the expiry of the limitation period for claims, whereby the limitation period for claims may vary in light of applicable legal provisions;
- **Fulfilment of obligations under the GDPR** – data related to data protection will be processed until they are no longer fit for purpose, you have effectively objected to the processing or until the expiry of the limitation period in relation to our liability as the Data Controller.
- **Fulfilment of tax law obligations** – data related to the requirement to fulfil tax obligations binding upon the Personal Data Controller will be stored for the period specified in the legal regulations, i.e. 5 years calculated from the end of the tax year in which fulfilment of the tax obligation became due,

#### **12. Rights in relation to the processing of your personal data**

We would like to inform you that under the GDPR you have the right to:

- access your personal data;
- rectify your personal data;
- delete your personal data;
- limit the processing of your personal data;
- object to the processing of your personal data;
- transfer your personal data.

- lodge a complaint with a supervisory authority (if you find that we are processing your data unlawfully, you may lodge a complaint to this effect with the President of the Office for Personal Data Protection or any other competent supervisory authority).

As the Personal Data Controller, we respect your rights under data protection laws, and we try to facilitate their implementation as much as possible. We point out that the above-mentioned rights are not absolute and therefore in some situations we may legally refuse to fulfil them. However, if we refuse to accept a request, it is only after a careful analysis and only if such a refusal is necessary.

### 13. Cookies

The Personal Data Controller on its website, similarly to other entities, uses the so-called cookies on its website, i.e. short text information saved on a computer, phone, tablet, or another website user's device. They can be read by our system, as well as by systems belonging to other entities whose services we use. We use cookies on the basis of your consent, except where cookies are necessary for the provision of services by electronic means.

Cookies that are not necessary for the provision of services by electronic means remain blocked until you have given your consent to their use. When you visit the website for the first time, we display a message asking for your consent together with the possibility to manage cookies, i.e. to decide which cookies you agree to and which you want to block.

Cookies perform many functions on the website, most often useful, which we will try to describe below.

- **service cookies** – used to provide electronic services; they are necessary for the operation of the website and cannot be disabled, e.g. Cookiebot;;
- **functional cookies** – to remember your preferences and adapt the website to your needs;
- **analytical cookies** - they are used to analyse how users use the website (how many open the website, how long they stay on it, which content arouses most interest, etc.). This enables constant improvement of the website and adaptation of its operation to users' preferences. We use Google tools such as Google Analytics to track activity and produce statistics,
- **marketing cookies** – to target behavioural advertising to you;
- **social media cookies** – used for the proper operation of social plug-ins or media players
- **session cookies** – stored in the memory of your browser until you close it;
- **permanent cookies** – they remain in the memory of your browser for the duration of their validity or until you delete them. They facilitate navigation on the website.

The Personal Data Controller uses his/her own cookies for the smooth operation of the website and third-party cookies detailed in the "Tools" section.

You can modify your cookies from our website. You can use this link <https://247.com.pl/en/#ustawienia-cookies> to modify your cookies.

In addition, you can manage your privacy using the following solutions (among others):

- blocking cookies within the framework of the web browser used. You can block all or selected cookies, including those relating to specific sites. You can delete already stored cookies and other data from plug-ins and sites,
- when using incognito mode, the cookies are deleted as soon as you close the window,
- by using plug-ins that provide control over cookies, such as <https://www.ghostery.com/>.

### **Google Ads**

When you play a video embedded in a website, Youtube cookies are installed on your device. If you play the video while logged into your Google account, the provider will be able to associate your activity with the account. To avoid this, log out of your Google account before playing the video.
